Fall has been identified as one of the major causes of various health issues among the older adults. These issues include deaths, emergency admissions for trauma as well as unintentional injuries. Statistical findings indicate that among the older adults of at least 65 years of age, damages resulting from falls have been attributed to fall-related deaths (Lord, 2013). Therefore, this makes it necessary to put into consideration the strategies of fall precaution. It has been established that one in every three older adults experience a fall. Falls have led to devastating outcomes for example head injury, hip injuries or other body fractures that require hospitalization. Anyone can trip and fall over. This information will, therefore, benefit other members of the public apart from the selected target audience.

The term trip is used to refer to the act whereby an individual's foot confronts an unexpected obstacle all over sudden. A trip could lead to a fall (Clemson & Munro, 2017).

As one of the safety practitioners, I would like to champion for safety among the senior citizens who are frequent victims of accidental falls. Therefore, in a bid to have the right solutions, it is essential to recognize the causes of falls. Quite a number of reasons have been put forward to explain the reasons behind the falling/tripping of the senior adults. For example, this entails; dizziness from intake of medication, some slips could be attributed to the aging effect for instance delayed reflexes or weakness of the muscle. Other falls could also be caused by stroke effects, disabilities, the weight of the fall victim, as well as other physical hazards that can block the person walking.

On the other hand, it is important to note that fall treatment could turn out to be very costly. Therefore, the factors mentioned above make fall precaution a vital topic that community members need to be enlightened on. It is essential to appreciate that falls can be prevented if caution is considered. I, therefore, hope that hospital visits due to falls shall be reduced after addressing this issue.

The solutions that shall be discussed in this project are practically easy to implement. Therefore, the first solution is to ensure that an individual walks on surfaces that are clean and free from any liquid or clutter.

Secondly, proper lighting of both the outside an inside of the rooms. This is to avoid any hazards that could be invisible in the dimly lit rooms.

It is essential for the caregivers to ensure that all the senior citizens have proper footwear with enough traction.

The immediate cleaning up of any liquid spills on the surface should be encouraged. This is because if left, the liquid tends to make the ground /surface more slippery. This could lead to more fall injuries.

Another solution is to provide non-skid rough rugs on the smooth surfaces, for instance, the tiled floors and bathrooms
